

## Education Quality Policy

1. The Education Quality Policy of Hugo Kołłątaj University of Agriculture in Kraków is compliant with the University's Mission and Strategy as well as with the provisions of commonly binding law.
2. The University demonstrates particular care for conducting education and scientific activity at a high level, participates in the creation of a common scientific space and higher education in the country and abroad, at the same time taking an active part in solving contemporary economic and social problems. The potential of the University used in teaching, research and implementation activities is based on multifaceted national cooperation, among others with economic and social entities, state and local government administration units, as well as on systematically developed international exchange.
3. The University fulfils its basic tasks with respect for tradition, in the spirit of humanism, freedom, tolerance, respect for ethical standards and creating attitudes of openness to people, knowledge and the world. The University authorities pay particular attention to the shaping of an appropriate profile of the graduate, consistent with the expectations of the labour market and society at large, taking into account the dynamics, changeability and diversity of the changes in civilisation.  
It is the graduates, as educated, creative and responsible specialists in a given field, who are the best reference of the University.
4. The primary objective of this Policy is continuous improvement of the educational processes at the University, enabling the achievement of socially recognised competences by students, doctoral students and listeners and professional satisfaction by graduates. Through the proper implementation of activities in this respect, the University offers the younger generation:
  - 1) the acquisition of modern knowledge, transmitted on the basis of current scientific achievements;
  - 2) the acquisition of specialised skills allowing the use of latest technologies and technical solutions;
  - 3) development of social competences to meet the needs of the modern world.
5. The main objectives expressed in the Quality of Education Policy are considered to be:
  - 1) effective and efficient implementation of the tasks resulting from the provisions of generally applicable law and strategic documents of the University;
  - 2) taking care of the realisation, at the highest possible level, of educational processes at the University, among others by:
    - supporting and strengthening the potential of the teaching staff responsible for the implementation of the education process, including the systematic improvement of their competences,



- adaptation to the needs and effective use of the University's research and teaching infrastructure,
  - supporting and strengthening the potential of administrative and technical staff in order to efficiently manage processes;
- 1) increasing the degree of internationalization of education and research;
  - 2) implementation and improvement of information flow between individual groups of internal stakeholders, as well as comprehensive information activities addressed to the University's external stakeholders;
  - 3) building and spreading a quality culture at the University, along with promoting ethical attitudes in the academic community.
6. The implementation of the assumed objectives of the Education Quality Policy is possible through the implementation, proper functioning and continuous improvement of the University Education Quality Assurance System. This requires the full commitment of the entire academic community of the University, which was expressed in the President of the University's declaration:
